

## **CONDITIONS FOR USE OF THE SERVICE** ***FREE Wi-Fi in Aeroporti di Roma [Rome Airports]***

### **1. Purpose**

These conditions define and govern the manner and terms under which Aeroporti di Roma S.p.A. (hereinafter “ADR”) provides the free wireless network (WI-FI - hereinafter “**service**”); By accessing the service, the user accepts these conditions of use and agrees to abide by them.

### **2. Provision of the service**

2.1 The service provides access free of charge, without any fee and/or cost of installation for the user, to the Internet in Wi-Fi mode, inside the airports Leonardo da Vinci in Fiumicino and G.B. Pastine in Ciampino.

2.2. The service may be used by airport users, through their compatible handheld devices (PC, notebook, smartphone, tablet, etc.) equipped with a certified WI-FI registered trademark network card, appropriately configured. Therefore, it remains the responsibility of users to equip themselves at their own expense with the technical equipment necessary to access the service and its proper configuration to connect to the Wi-Fi network in Aeroporti di Roma.

2.2. ADR makes no warranty to the Service; the service is provided with the applicable safety obligations, through the use of shared frequency bands and no protection from interference. Therefore availability of the service and its quality are not guaranteed. The service is provided on an open network, not protected by traffic encryption. Therefore, its use is not recommended in cases of communications containing confidential data.

### **3. Types of Services offered**

ADR offers the service FREE WI-FI for accessing Internet for free and without prior registration of the user.

### **4. Guarantees and Commitments by the user**

The user is aware of having to use the service in compliance with all applicable laws and regulations and respecting others.

To this end, the user is aware and consequently agrees:

- (i) not to use the service to commit or facilitate the commission of crimes of any type;
- (ii) that any material placed on the network does not violate copyright or other intellectual or industrial property rights;
- (iii) not to use or allow others to use the service for communications or acts against morality or public order or for the purpose of disturbing the peace, and to damage or breach or attempt to breach the secrecy of correspondence;
- (iii) not to input into the network, using the service, information that may be pornographic, obscene, profane or defamatory in form and / or content;
- (iv) not to use the service to send unsolicited commercial communications (spamming), unsolicited mass mailing and requests to individual e-mail addresses/network IDs (mail bombing), and unauthorized attempts, whether successful or not, to access any addresses or computer resources not owned by the user (spoofing);
- (v) to adopt appropriate means of protection from computer viruses that may cause damage to third parties or to the network itself;
- (vi) using the service in accordance with these conditions of use and closely following the technical instructions given by ADR.

To this end, the user agrees to indemnify Aeroporti di Roma from all claims and demands of any kind advanced by third parties in connection with the use of the service.

### **5. Suspension or other disruptions in delivery of the Service**

5.1 During the conditions and standards of service, interruptions, suspensions, delays or malfunctions in providing said service, may occur.

5.2 The user acknowledges that ADR will not be responsible for any inconvenience and/or damage caused to the user or to third parties as a result of such interruptions, suspensions, delays, or malfunction of the service, including those arising from changes and/or maintenance that is unplanned or unforeseen or technically necessary, or planned and predictable. In this case, however, ADR will strive to minimize any inconvenience to the user, possibly providing the necessary information and/or, if possible, adequate notice.

5.3 In the case of change in technical conditions and terms of use that prevent the normal delivery of service, ADR will have the right to terminate, at any time, supply of the service, subject to making reasonable endeavours to give adequate notice and restore the service.

### **6 - Confidentiality**

The data collected during the use of the Service is never linked with directly identifiable users, but consists of technical information relative to the terminal used. In providing its service, Aeroporti di Roma, identifies the device used to connect via its physical address, or MAC Address, and is aware of the existence of the log registry of the connection. The Mac Address and logs are absolutely confidential, do not allow ADR to identify the user, but may be disclosed exclusively to the competent Authorities upon their formal request.

Personal data of users will not be processed as part of the FREE WI-FI service.
