In the wake of the letter prot. U0020348 of 08/05/2020 with which ADR initiated the consultation of the users of the Fiumicino and Ciampino airports regarding the proposal to update the regulated fees relating to “tariff year” 2021 (01.03.2021 - 28.02.2022), we shall communicate the following.

As part of the procedures of the aforementioned users’ consultation – launched by ADR on August 14 with the publication of relevant information material – the public hearing with users is scheduled and confirmed for October 13, at 10.00 am CET.

However, in consideration of the health emergency from COVID-19 still in progress and of the regulatory measures aimed at containing and managing it, in order to allow maximum users’ participation, we inform you that the joint public hearing for the users of Fiumicino and Ciampino will take place exclusively as a webcast via the Webex platform.

In order to easily allow the access and recording procedure, the recipients of this letter are invited to transmit – by 09.00 am CET on 9 October to e-mail address infoutenti@adr.it – the name of their representative (or any associated) who will also be equipped with suitable powers for the receipt and acceptance of the minutes of the meeting, with the relative e-mail address at which ADR will notify for access to the Webex platform.

Therefore, contrary to the provisions of our note dated 05/08/2020, no meeting will be held on the same date at the Garden Inn Hotel in Fiumicino.



The widest participation of users in the public hearing of October 13 is hoped for, also for the purpose of a fruitful joint analysis of expectations on airport infrastructure and air transport developments. Therefore, the recipients are kindly requested to give the maximum dissemination of this communication to users and associates.

For matters that are not integrated with this communication, contents and provisions of our previous prot. U0020348 of 08/05/2020 remain fully valid.
